SUBJECT: Policy# 6690 Privately Owned Culverts (Consent)

**ENGINEERING** 

#### **RECOMMENDATION:**

Approve a new policy for privately owned culverts as recommend by the Engineering Committee on January 17, 2017.

#### **BACKGROUND**:

The District is creating a policy to direct staff in the management of privately owned culverts and gives clarity to the Districts requirements for the privately owned culverts.

The policy addresses numerous issues that have been encountered by the District relevant to privately owned culverts on the canals. These issues have been by developers, private landowners, and District activities. The policy will create a consistent direction for the managing of privately owned culverts by the District or external to the District.

The policy is recommended for approval by the Engineering Committee and staff.

#### POLICY MANUAL

POLICY TITLE: Privately Owned Culverts

POLICY NUMBER: 6690

The intent of this policy is to guide the District related to the management of Non-District culverts that support access and convey water within the District. The District operates and maintains approximately 450 miles of open canals. District canals and the related facilities are designed and constructed to accommodate District managed water supplies, plus some limited intrusion flow. Culverts provide access over District canals for items such as vehicles, pedestrians, bicycles, animals, storm water, and other utilities. The majority of culverts are privately owned with little or no use by District and are classified as private culverts

Poorly maintained culverts create various problems for District water deliveries such as capacity reduction caused by sediment, collapsing, or collapsed culverts which can substantially impact the Districts ability to deliver water to its customers. Impacts include loss of water to water treatment plants, interruption of delivery to irrigation customers, and overtopping of canals causing property damage. These failures are a risk to public health and safety.

- 6690.1 Private culverts shall be constructed only with an approved encroachment permit issued by or under the supervision of the District.
- 6690.2 District will establish a construction standard for all culverts. Installers shall follow the Districts current standards for construction. Installer may apply for modifications to the standards which must be preapproved by the Engineering Manager.
- 6690.3 Maintenance of private culverts shall be the responsibility of the landowner or underlying parcel owner or assigns.
- 6690.4 Replacement, repair, or removal of private culverts shall be at the sole cost of the landowner.
- 6690.5 District has the right to repair or remove any private culvert that encumbers the Districts ability to convey water. Those costs shall be the responsibility of the landowner.
- 6690.6 If repair or removal of a private culvert in a non-emergency situation is warranted the District will notify the underlying parcel owner of the necessary work. If the work is not completed after allowing sufficient amount of time, the District shall perform that work at the sole cost to the landowner.

6690.7 District has the right to use or work on any private culvert to convey water. District shall have the right of ingress and egress across any structure or installation at any and all times. The District without charge must be able to use any improvements installed by Permittee within the encroachment areas as it deems necessary to conduct its operations.
