# **Recreation Activities Report**

October 15, 2019 - January 21, 2020

## Scotts Flat Campground

Projects in Progress or Completed:

- All campground staff have been working on the storm cleanup, lots of leaves and pine needles, broken branches, and down trees
- Reservation season started on January 2, 2020. The online reservation system worked perfectly. Staff has learned that it is necessary to test the online reservation system for problems and errors prior to officially opening for reservations. By being more proactive, the system is more user-friendly and reliable; customers use it more which cuts down on the phone calls
- For the most part, Faucherie is booked the 2020 camping season
- Sewer work complete at Gate 2 bathroom, we had tree roots growing into our pipes
- One of the biggest problems the maintenance crew struggles with is mold in the showers. Best Sandblasting worked on three of the bathrooms, blasting all the old paint and caulking; re-sealing and painting will happen when the weather warms up
- There is a massive amount of mastication work going on; on the outskirts of the campground (Scotts Flat Road, Casci Road and Pasquale Road), with positive feedback received from the District neighbors
- The CCC, California Conservation Corp., was working in Nevada City and near Smartsville in November and December and needed a secure and reasonably priced place to stay. Recreation was able to set them up at Gate 1, down in the lower loop

### Future Projects:

- Painting all the showers
- Continue work on the interior of the Ditch Tenders House

### Orchard Springs Campground

Projects in Progress or Completed:

- Bringing in extra revenue by allowing the tree companies who are working for PG&E to stay an extended amount of time at the campground, longer than the 14-day rule
- Recreation maintenance staff has been working on repairing or replacing bathroom fans, lights, shower coin machines and light switches

Future Projects:

- Order picnic tables and umbrellas for the store picnic area
- Install a shade structure over the picnic and play area

### Long Ravine Campground

Projects in Progress or Completed:

- Replacement of the water system started in November. The campground has been closed to camping to allow NID to get in and complete the work; campers are being sent to Orchard Springs
- During the water system upgrade, upgrading our RV sites is also occurring, leveling out the sites, re-rocking and upgrading the electrical to the sites
- PG&E has been doing a lot of tree work in the campground

### Future Projects:

- Recruiting one camp host
- Restripe the boat launch and overflow parking lots
- February 2020, replace the remaining old wooden boat slips with plastic slips

# Peninsula Campground

Projects in Progress or Completed:

- Peninsula is closed for the season effective September 12, 2019
- The transformer had to be replaced in early December
- Staff is in the process of fixing a few leaks in the bathrooms and updating the shower coin machines

#### Future Projects:

- Best Sandblasting to work on the showers
- Upgrading the inside of the bathrooms with new paint, flooring and bathroom fixtures
- Creating a day-use/swim area

### Upper Division, Jackson Meadows Campground

Projects in Progress or Completed:

- Jackson Meadows is closed for the winter season
- Completed and sent the 2020 Operating Plan to the USFS for their authorization, and awaiting their response

### Future Projects:

- Tree work at Sawmill dispersed sites
- Replacing all the campground barriers, this will help with unauthorized parking and crowding within the campgrounds
- Ensuring there are three camp host for the 2020 season

### Combie Reservoir

Projects in Progress or Completed:

• All is quiet out at Combie during the winter

Future Projects:

• Determine and start the clean-up process for all the non-authorized encroachments on Combie and the District's other reservoirs

#### Greenhorn Campground

Projects in Progress or Completed:

• The Liserra's (concessionaires) are in the same transition as the District, closing everything up for the winter, making repairs as needed and looking towards the 2020 season

#### Future Projects:

- Continue to help the Liserra's when necessary and feasible. It's nice to work as a team
- Install our Quagga Mussel sign for self-inspection and get Greenhorn staff implementing and supporting the District's self-inspection program
