### RECOMMENDATION:

Receive and File the *Notice of Removal from Schedule for Western Electricity Coordinating Council (WECC) Annual Self-Certification for 2015 Monitoring Period* as recommended by the Water and Hydroelectric Operations Committee (WHO).

## **BACKGROUND:**

As a NERC Compliance Registry (NCR) Listed Entity, NID is commonly required to submit a WECC Annual Self-Certification Report to WECC. Self-Certification is an attestation by a Registered Entity of compliance or non-compliance with NERC Reliability Standards.

On October 14, 2015, WECC Notified NID that an Annual Self-Certification Report for the 2015 Monitoring Period would not be required of NID.

As authorized by NID Board Policy 9400, the Internal Compliance Program approved by the Board of Directors on January 22, 2014 requires that the results of the Annual Self-Certification be presented to the Board of Directors. As no Self-Certification is required by the regulatory authority for the 2015 Monitoring Period, there is no report to present to the Board of Directors. However, to demonstrate compliance with District Policies and Programs during a future WECC audit, Staff recommends that the Board of Directors Receive and File the attached notification as evidence.
