RECOMMENDATION:

Review and approve the 2020 Mid-Year Budget Amendment.

BACKGROUND:

As a practice, the District began performing mid-year and year-end budget amendments in 2019. This industry practice is beneficial to align current expenditures to the budget while providing a more accurate benchmark for the next year's budget.

The proposed budget amendment increases a total of 17 different accounts by \$739,044 and reduces 16 different accounts by this same amount. The largest increases are to 51201 - Temporary Salaries and 52503 - Equipment Maintenance (\$256,500), and the largest reductions are to capital spending (\$266,800).

Strategic Goal

Performing mid-year and year-end budget amendments ensures account level management occurs, helping achieve Strategic Goal number 1 by improving the Board's ability to manage the District's financial resources.
