



RESOLUTION NO. 2026-16

OF THE BOARD OF DIRECTORS OF THE NEVADA IRRIGATION DISTRICT

**DECLARING AN ELECTION BE HELD IN ITS JURISDICTION,
REQUESTING THE BOARD OF SUPERVISORS TO CONSOLIDATE THIS ELECTION
WITH ANY OTHER ELECTION CONDUCTED ON SAID DATE,
AND REQUESTING ELECTION SERVICES BY THE COUNTY CLERK
COUNTY OF PLACER**

WHEREAS, this District Governing Body orders an election to be held in its jurisdiction on November 3, 2026; at which election the issue(s) to be presented to the voters shall be:

NOMINATION OF CANDIDATES FOR THE GOVERNING BODY OF THE NEVADA IRRIGATION DISTRICT

1. Said election shall be to fill a vacancy for the following Board Member(s) who resigned and/or whose term(s) expired:

<u>Incumbent's Name</u>	<u>Division</u>	<u>Regular/Short Term</u>
Earl Stephens	4	Regular

2. Said Directors for this District are elected by Division. Districts are split into areas; only those voters residing in the area may vote for candidates who run in the area; and
3. Said District has determined the following election particulars:
 - The length of the Candidate Statement shall not exceed 200 words
 - The cost of the Candidate Statement shall be paid by the Candidate; and
4. Said District does not request that a measure be decided at this election; and
5. Nevada Irrigation District has determined the following election particulars:
 - In the case of a tie vote, the election shall be determined by LOT.
 - The County Clerk is requested to provide election services. All applicable costs for election services provided by the Placer County Elections Office will be paid for by the District.

6. The District hereby certifies that (please check one):

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Placer is hereby requested to:

1. Consolidate the election with any other applicable election conducted on the same day;
2. Authorize and direct the County Clerk, at the Nevada Irrigation District's expense, to provide all necessary election services.

BE IT FURTHER RESOLVED, that this Resolution shall be considered a Notice of Election and Specification of Election Order if applicable.


