BACKGROUND:

The report provides departmental financial efficiencies consistent with staff's commitment to investigate costs savings and revenue sources for the benefit of our ratepayers and community.

Due to staff's efforts, the District realized \$6,038,574 in financial efficiencies and \$245,790 in additional revenues for the fiscal year. Since the inception of these efforts in 2014, the District has realized \$28,523,946 in efficiencies.
