## ***MAINTENANCE***

### **RECOMMENDATION:**

Award a contract to C & D Contractors, Inc. of Nevada City, California, in the amount of \$164,264.00, for the Scotts Flat Campground Work, NID Project No. 2220, and authorize the General Manager to execute the necessary documents.

### **BACKGROUND:**

The project involves the replacement of approximately 3,500 linear feet of 2-inch PVC water pipeline and approximately 460 linear feet of 2-inch electrical conduit at the Scott's Flat Campground Gate #2. The work will also include the installation/replacement of 18 hose bibs and 5 electrical pull boxes throughout the campground and asphalt restoration. The installation is the completion of a multiple year project which has completed the total replacement of the water system at the Scott's Flat Recreation facility. This pipeline replacement was supported from concerns of the Nevada County Department of Health from a recent annual inspection. Future water system replacements at other NID campgrounds are part of the five-year budget.

The required completion date for the project is Thursday, February 28, 2019.

District staff solicited bids from seven pipeline contractors, whose work is known by the District, four of which responded (see attached Bid Results and below). Bids were publicly opened on October 11, 2018 and C & D Contractors was the low bidder.
