#### **RECOMMENDATION:**

Adopt a resolution approving a budget amendment and FY2025 contribution to the CEPPT in the amount of \$2,000,000.

#### **BACKGROUND:**

On October 23, 2024, the Board approved establishment of the District's CEPPT Pension Trust. This was after the adoption of the 2025 Budget; therefore, staff is recommending a budget amendment to make an annual contribution for FY2025 in the amount of \$2,000,000. Going forward the annual contribution will be part of the annual budgeting process and adoption.

#### **BUDGETARY IMPACT:**

This action requires a budget amendment in the amount of \$2,000,000 for contribution revenue and expenditures. Broken out by fund as follows:

- a. Fund 85 contribution revenue amendment \$2,000,000
- b. Fund 10 contribution expenditure \$1,194,717
- c. Fund 30 contribution expenditure \$58,221
- d. Fund 50 contribution expenditure \$375,897
- e. Fund 70 contribution expenditure \$371,165

## APPROVAL AUTHORIZING A BUDGET AMENDMENT OF \$2,000,000 FOR FY2025 CEPPT TRUST CONTRIBUTION

WHEREAS, in 1981 Nevada Irrigation District adopted resolution establishing participation in the California Public Employees' Retirement System (CalPERS); and

**WHEREAS,** in 2019, CalPERS opened for participation the California Employers' Pension Prefund Trust (CEPPT) fund. It is a Section 115 Employer Pension Contribution prefunding trust that allows state and local public agencies that participate in defined benefit public pension system to voluntarily prefund employer contributions; and

WHEREAS, The District began participation in the CEPPT trust October 2024.

#### NOW, THEREFORE, BE IT RESOLVED

- 1. That the Board of Directors hereby approves and directs staff to make the FY2025 contribution to the trust in the amount of \$2,000,000
- 2. That the Board of Directors hereby approves a budget amendment as follows:

  - b. Fund 10 contribution expenditure \$1,194,717
  - c. Fund 30 contribution expenditure \$58,221
  - d. Fund 50 contribution expenditure \$375,897
  - e. Fund 70 contribution expenditure \$371,165
