SUBJECT: 2019 Bowman Spaulding Canal Liner Replacement (FATR#2230)

RECOMMENDATION:

Award a construction contract to Hanson Brothers, Inc. for the replacement of a section of the Bowman Spaulding Canal Liner Replacement in the amount of \$489,819.00, and authorize the General Manager to execute the appropriate documents.

BACKGROUND:

The 2019 Bowman-Spaulding Canal Liner Replacement Project will involve the replacement of 475 linear feet at a cost of \$489,819.00 or \$1031.19 per foot of aged and badly deteriorated concrete canal liner. This segment of the canal will be replaced with a new bottom and sloped walls and connection to the previous replacement work in 2018. Construction will improve the canal section by increasing structural integrity.

In comparison, the 2018 Bowman Spaulding Canal Liner Project (FATR#2146) consisted of replacement of 400 feet of canal liner replacement upstream of this current project. The cost for that work was \$450,456.80 or \$1126.14 per foot and was completed by Hanson Brothers Enterprises. The 2018 project included a stilling well and bridge installation that were needed for that section of canal causing the higher costs per foot. The current section of canal does not have those requirements.

Quotes for the construction of the project were requested from eight qualified contractors (C & D Contractors, Hansen Brothers Enterprises, Gateway Pacific Contractors, Lorang Brothers Construction, McGuire & Hester Construction, Syblon Reid Construction, T & S Construction, and TCB Industrial, Inc.). Quotes were opened on February 21, 2019. Three quotes were received as shown below

and Hansen was the low bidder in the amount of \$489,819.00 or \$1031.19 per foot.

The project will not change the character, scope, or size of the canal. Therefore, it is considered a maintenance project and categorical exemption per sections 15301- Existing Facilities and 15302 – Replacement or Reconstruction of the California Environmental Quality Act.

This project directly relates to Strategic Goal 1 of the 2016 -2018 Strategic Plan to strengthen reliability and redundancy of facilities as indicated on the Districts website at https://nidwater.com/wp-content/uploads/2016/04/2016 2018-Strategic-Plan.pdf.

Staff is recommending that the Board award the contract with Hansen Brothers Enterprises in the amount of \$489,819.00.

BUDGETARY IMPACT:

This project is budgeted in the Reservoirs, Dams and Waterways (50112-52921), the budget for 2019 is \$1,700,000. After this commitment, there will remain 1,172,000 in this account.


