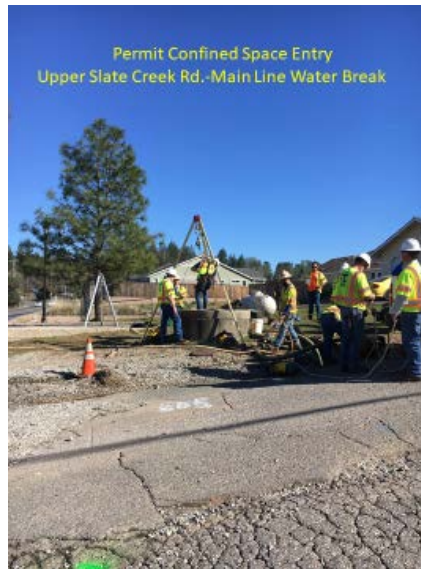


# MONTHLY SAFETY ACTIVITIES
