## **Scotts Flat Campground**

## Projects in Progress or Completed:

- Educating our day users, boaters and campers on COVID-19 safety has been quite a challenge. Our staff continues to do an awesome job at trying to keep everyone safe.
- The smoke from the fires has slowed down our day users and boaters but not our campers.
- During the Jones Fire, we had six families who were evacuated stay with us at Scotts Flat. They camped at Gate 1 at no charge, no one stayed longer than a week.
- As of October 1, Scotts Flat, Orchard Springs and Long Ravine campgrounds will transition back to first come first serve, until next season.

## Projects in Progress or Completed:

- NID's Hydro welders are replacing the gate and putting up a heavy-duty fence at Faucherie to keep people out of the campground during unexpected closures and off-season closures.
- All the picnic tables at Canyon Creek Campground have been pressure washed and resealed.
- On September 7, USFS closed all developed campgrounds and dispersed camp areas in the Jackson Meadows Complex and Bowman Corridor, due to high fire danger. They also are not allowing any fires, of any kind within the campgrounds or dispersed areas.
- On September 9, the USFS extended their closure to add no one can be on USFS lands, drive on USFS roads or using their trail systems.

#### Future Projects:

- We still have two trees to take out at Canyon Creek.
- Tree work at Sawmill dispersed sites.
- Replacing all the campground barriers.
